Minutes of the Ordinary Meeting of Stow Bardolph Parish Council Held at Stow Bridge Village Hall on Tuesday 11th March 2025

1. To receive apologies for absence

1.1 Apologies were received from Parish Councillor Richard Gilbert (illness) and Borough Councillors Colin Rose & Vivienne Spikings.

2. To receive any declarations of Interest in items on the agenda

2.1 None.

3. To approve and sign the minutes of the meeting held 14th January 2025

3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

4. Clerk's report (for information only)

- 4.1 Information regarding the current consultation on Devolution, will be forwarded to Council Members.
- 4.2 The Clerk is using the trial version of Parish Online and finding it particularly beneficial in assisting with queries regarding property boundaries.
- 4.3 Correspondence from St Peter's Church in Stow Bridge thanked the Council for their contribution to the Churchyard maintenance and confirmed a slight increase in costs for the forthcoming year.
- 4.4 There were no updates on the Allotment Rent Review the Clerk will follow this up in time for the next meeting.
- 4.5 The Clerk requested that new IT equipment be purchased, as the current laptop and the printer are no longer fit for purpose. Council Members requested quotations for new equipment be brought to the next meeting for review.

5. To receive updates from Borough and County Councillors

- 5.1 Cllr Dawson said the role of Member for Rural Economy is being removed; however, any projects already underway as part of this role will continue.
- 5.2 Cllr Dawson also confirmed that rural areas will get one extra verge cut this year.
- 5.3 Cllr Dawson expressed his hope that extra funding will be available to him in the next financial year, which will enable him to support local community projects; he will provide more details as soon as they become available.

6. Open Forum for public participation

One member of the public was present and expressed the following:
a) Request for more details on the vacancy of Trustee to the Hundred Acre Charity. The
Clerk explained more about the charity, the role and the Parish Council's involvement in

appointing Trustees.

b) Concerns that the junction of High Bridge Road and The Drove is dangerous, particularly to motorists who are unfamiliar with the area, as they cannot easily understand the priorities of the junction due to poor road markings. The Clerk will report this to Norfolk County Council (NCC) Highways and ask them to review as a matter of urgency.

7. To discuss any Highway Matters

- 7.1a A report on all previously identified issues, including details of the latest updates from Norfolk County Council (NCC) Highways Department is attached at appendix i.
- 7.1b After a discussion regarding lack of progression on previously reported items, Cllr Dawson offered to follow this up with NCC Highways on behalf of the Council.

- 7.3 The Clerk gave a verbal report on the meeting that took place between Marshland South Parish Councils and NCC Highways regarding Parish Council's taking on responsibility for verge cutting and maintenance. After discussion it was agreed that it would not be cost effective for the Council to take on this responsibility at the present time.
