Minutes of the Ordinary Meeting of the Stow Bardolph Parish Council Held at Stow Bridge Village Hall on Tuesday 11th July 2023

1. To receive apologies for absence

1.1 Apologies were received from Borough Cllr Mr C Rose and County Cllr Mr C Dawson.

2. To receive any declarations of Interest in items on the agenda

2.1 None

3. To approve and sign the minutes of the meeting held 16th May 2023

3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

4. Clerk's report (for information only)

- 4.1 The Clerk confirmed that new Councillors will receive an induction before the next meeting.
- 4.2 All end-of-year finance has been completed.
- 4.3 The new notice board has arrived and will be installed later this month.
- 4.4 Correspondence had been received regarding parking on The Causeway; as the Council has no powers to intervene, the matter has been passed to the local Police Safer Neighbourhood Team.
- 4.5 The Clerk gave a verbal update on the Lifting Equipment project that was discussed at the last meeting; the project is progressing quickly and a meeting for interested parties will be held on 21st July in King's Lynn. It looks likely that a new charity or Community Interest Company could be set up to manage the scheme; the Clerk has asked to be kept updated on the project and will feed this back to the Council at a later meeting.
- 4.6 All other matters that the Clerk has been working on are covered by the agenda.

5. To receive updates from Borough and County Councillors

- 5.1 A report from Cllr Rose had been forwarded to Members ahead of the meeting (a copy is available on request from The Clerk).
- 5.2 Cllr Dawson had sent information regarding verge cutting ahead of the meeting but was not available to give a further update and will therefore be asked to email any further details as they become available.

6. Open Forum for public participation

6.1 No members of the public were present.

7. To discuss any Highway Matters

- 7.1 A report on all previously identified issues had been circulated to Members ahead of the meeting (and is attached at appendix i).
- 7.2 The hedges adjacent to Woodlakes Park are becoming very overgrown and problematic for larger vehicles passing that way, as well as making it difficult for pedestrians to walk along

- the road safely. This has already been reported to NCC Highways; the Clerk will write to the landowner.
- 7.3a The invoice for the work to extend the footpath in Barroway Drove has still not been received.
- 7.3b No updates on when work to complete the Trod between Stow Bridge and Wimbotsham will commence was available; the Clerk will contact Wimbotsham Parish Council to ask for an update.
- 7.3c Details of this year's Parish Partnership Funding Scheme have been received; there are currently no projects that have been identified by the Council as suitable for this funding.

8. To discuss any Street Light Matters

- 8.1 No issues were reported.
- 8.2 The current Streetlighting Maintenance Contract will end on 1st September. Two quotes have been received and a third has been requested. The Council **RESOLVED** that this matter should be delegated to Clerk, who will liaise with the Chairman to agree a new Maintenance Contract as soon as possible, with details to be reported at the next meeting.

9. To discuss Planning Matters

- 9.1 The Council noted the results of previous applications and the responses from the Planning Advisory Group to applications received for consultation since the last meeting (see report attached to July 2023 agenda).

- 11.1 The following policies and procedures were reviewed and approved:

- 11.2a The Allotment Policy and Tenancy document was reviewed and agreed without amendment; however, the review prompted a discussion around whether Allotment Tenancies were the correct agreement for the parcels of land that the Council currently let, as a reduction in the number of tenants means that they are now much larger and therefore being farmed for agricultural purposes. It was agreed that the best course of action is likely to be that the current tenancies are transferred to Agricultural Farm Tenancies. The Clerk will research this further and report information back to the Council at the next meeting.
- 11.2b Historically, some allotment holders had not been paying drainage rates, but the reason for this was unclear. It was agreed that all allotment holders should incur drainage rates as the Council pay drainage rates on all allotment land, and therefore rent notices for next year will reflect this.
