property that already had a breeding licence in place, and therefore assumed this meant the applicant also had in place all the necessary procedures for dealing with noise pollution and waste disposal, as the parish council would have expected these matters to have been dealt with during the licence application process; however, it now appears that this was not the case.

The parish council has studied carefully the supporting documents on the planning portal, including the objections from neighbouring properties, and feels it must withdraw its support this application, as the current situation appears to be having a detrimental effect on nearby residents, especially in terms of noise pollution.

The parish council notes the CNN Team have asked for clarification on several pertinent points regarding how the site will be managed; the parish council is willing to be guided by the CNN Team response and would be minded to support any conditions that they recommend, but at present the parish council's decision is that they object to this application.
