Temporary Traffic Regulation Order 2025
Section 14(2) of the Road Traffic Regulation Act 1984

Stow Bardolph (WTRO6296) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to Anglian Water emergency pipe repairs the use by vehicles (of any class) of the Barroway Drove from 105m southwest of its junction with Cuckoo Road for 40m south westwards (the "Road") in the Parish of Stow Bardolph will be temporarily prohibited/restricted.

Alternative route is via: The Drove, Lady Drove, Downham Road, Bridge Road, Station Road, Western Bypass A1122, Southern Bypass A1122, Downham Eastern Bypass A10, Bexwell Road, Downham - Wimbotsham Bypass A10, Stow Bardolph Bypass A10, Stow Bridge Road, The Causeway, West Head Road, Highbridge Road (Downham West, Stow Bardolph, Downham Market, Wimbotsham, Ryston)

The works promoter for this restriction/closure is: Anglian Water.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 9th to 15th October 2025 but the Road may continue to be closed/restricted until the 29th October 2025 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 29th October 2025 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

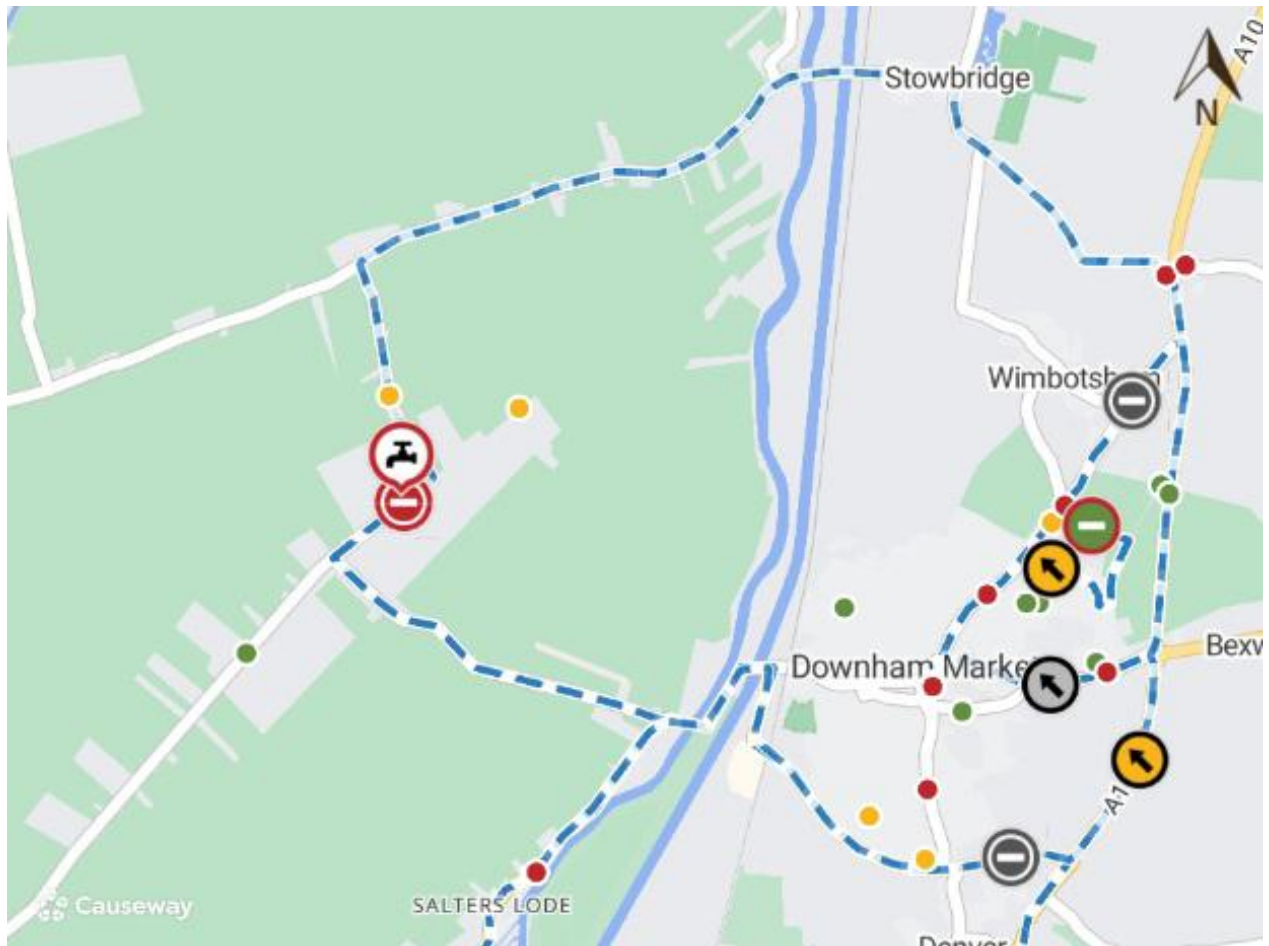
