Minutes of the Ordinary Meeting of Stow Bardolph Parish Council Held at Barroway Drove Village Hall on Tuesday 9th September 2025

The meeting commenced at 7.30pm

One member of the public was present.

1. To receive apologies for absence

- 1.1 Apologies were accepted from Parish Councillors' Stephanie Dent (away) & Raymond Hudson (away).
- 1.2 Apologies were received from Borough Councillor Vivienne Spikings.

2. To receive any declarations of Interest in items on the agenda

2.1 None.

3. To approve and sign the minutes of the meeting held Tuesday 8th July 2025

3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

4. Clerk's report (for information only)

- 4.1 Gov.uk email addresses are now operational for all Councillors and the Council's website address has been changed to www.stowbardolph-pc.gov.uk.
- 4.2 Local Government Pay Scales for 2025-26 have been agreed.
- 4.3 Allotment Rent Invoices have been sent out; no further communication has been received regarding the rent review by the Council's landlord.
- 4.4 A report of rubbish in the garden of a property in Barroway Drove has been received an passed on to the Borough Council.
- 4.5 The Clerk reminded Councillors of their responsibility to complete (and keep up to date) their Register of Interests Forms, which are held by the Borough Council.

5. To receive updates from Borough and County Councillors

- 5.1 Regular updates on the progress of Local Government Reorganisation continue to be received from both the Borough and County Council; there is currently no indication of when a decision on any changes will be made.
- 5.2 Cllr Rose confirmed that the West Lynn Ferry is now fully operational.
- 5.3 Cllr Dawson updated the Council on his work around addressing the issue of pavement parking.
- 5.4 Cllr Dawson confirmed that the issue of mud being left on the roads by farm traffic is being addressed.

6. Open Forum for public participation

6.1 A member of the public expressed concern about farmers choosing to chop straw after harvest rather than baling it, as the dust from this process can affect air quality for residents. The Clerk responded that this would be a matter for the Environmental Health Team at the

Borough Council, and any concerns should be reported directly to them. Cllrs' Brighton and Gilbert responded that the quality of the straw this year most likely dictated that the farmers had no other option but to chop it.

7. To discuss any Highway Matters

- 7.1a A report on all previously identified issues, including details of the latest updates from Norfolk County Council (NCC) Highways Department is attached at appendix i.
- 7.1b Council Members noted the Highways Department responses acknowledged two incidents where a boundary fence was confirmed to be encroaching Highways land, but had chosen not to insist on the fences being moved; the Council asked the Clerk contact the Highways Department to express their disappointment in these decisions and to ask if Norfolk County Council will accept liability for any accidents that happen as a result.
- 7.1c The hedge at Rose Farm on Lady Drove has still not been cut and is significantly reducing visibility on the bend. The Clerk will report the matter to Highways again.
- 7.2 New issues reported are listed at appendix ii.
- 7.3a Correspondence from a resident concerned about pedestrian safety on Low Road was noted.
- 7.3b Correspondence from a resident concerned about speeding on West Head Road was noted.
- 7.3c A meeting will be arranged between the Council and a representative from the Highways Department, where these two items of correspondence will be discussed, along with the various other ongoing concerns within the parish.
- 7.4a A revised estimate of £18,500 to complete the Trod from Stow Bridge Village Hall to the bus stop on The Causeway had been received from NCC Highways. It was agreed alternative quotes should be sought.
- 7.4b It was agreed that an application to The Parish Partnership Fund should be made for 50% of the estimated cost of the Trod. The Council **RESOLVED** to delegate responsibility for making the application to the Clerk.
- 7.5 Poorly signed road closures continue to be an issue within the parish and beyond; it was agreed that Working Party consisting of Cllr M Brighton, Cllr D Brighton and Cllr Hudson be formed to look in detail at the appropriate wording required for bespoke signage; their conclusions will be reported back to the next Council meeting.

8. To discuss any Street Light Matters

8.1 Four faults were reported in August; three of these have been repaired but one (outside 97 The Drove) needs a lantern replacement, which will cost £395 plus VAT. The Council **RESOLVED** to approve the repair.

9. To discuss Planning Matters

- 9.1 The Council noted the report from the Planning Advisory Group (attached to September 2025 agenda).
- 9.2 The Council reviewed one planning application:
