Minutes of the Ordinary Meeting of the Stow Bardolph Parish Council Held at Stow Bridge Village Hall on Tuesday 8th November 2022

The meeting commenced at 7.45pm

Before the business of the meeting was addressed, two representatives from Anglian Water gave an overview of the Strategic Pipeline Project that will run through the parish; with work due to commence early next year, they explained the processes and techniques that will be used to build the new 90km pipeline between Grantham, Peterborough and Bexwell, with the aim of increasing the reliability of supply and reducing the number of homes and businesses which currently rely on a single pipeline for all their water needs.

1. To receive apologies for absence

1.1 Apologies were accepted from Parish Councillor Mr R Hudson and Borough Councillors Mr C Rose & Mrs V Spikings.

2. To receive any declarations of Interest in items on the agenda

2.1 Cllr Dent declared a non-pecuniary interest in agenda item 11e (request for donation towards shed by St Peter's Church)

3. To approve and sign the minutes of the meeting held 4th October 2022

3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.

4. Clerk's report (for information only)

- 4.1 The Clerk reported that the pay award for local government staff on National Joint Contract terms and conditions has been agreed; the changes are effective from 1 April 2022 and will need to be backdated in the next payroll run.
- 4.2 All other matters that the Clerk has been working on are covered by the agenda.

5. To receive updates from Borough and County Councillors

- 5.1 Cllr Long reported that whilst he is no longer a Cabinet Member at the Borough Council, he has taken on extra responsibilities with the County Council, including joining the Scrutiny Committee and being made Disability Champion for Norfolk.
- 5.2 Cllr Dawson had sent an update ahead of the meeting, which was circulated to all Members; he also reported that he had recently met with Norfolk County Council's Head of Paid Services, Tom McCabe, within his Marshland South constituency, so that Mr McCabe could see first-hand some of the issues faced by rural West Norfolk communities; Cllr Dawson will continue to lobby for a more joined-up approach to planned road closures.

6. Open Forum for public participation

6.1 No members of the public were present.

7. To discuss any Highway Matters

- 7.1 A report on all previously reported issues had been circulated to Members ahead of the meeting (and is attached at appendix i).
- 7.2 The grass verge outside Stow Bridge Village Hall is not being cut; Highways Department to be asked if this can be included when other verges are cut.
- 7..3 A reply from Anglian Water regarding the leak on The Causeway had been received, via Liz Truss' office, stating that they have undertaken extensive investigations and concluded that they are satisfied that the water main is not leaking, and will therefore not be taking any further action at the present time.
- 7.3 No other Highways Matters were discussed.

8. To discuss any Street Light Matters

8.1 No faults were reported.

9. To discuss Planning Matters

- 9.1 The Council noted the results of previous applications and the responses from the Planning Advisory Group to applications received for consultation since the last meeting (see report attached to November 2022 agenda).

Cllr Dawson confirmed that Norfolk County Council were opposed to the application on the grounds of the negative impact on local infrastructure and the additional traffic the facility would bring to the area, increasing both congestion and pollution.
