- 2.1 None.
- 3. To approve and sign the minutes of the meeting held Tuesday 9th September 2025
- 3.1 The minutes of the meeting were approved without amendment and signed by the Chairman as a correct record.
- 4. Clerk's report (for information only)

- 6. Open Forum for public participation
- 6.1 No members of the public were present at the meeting.
- 7. To discuss any Highway Matters
- 7.1a A report on all previously identified issues, including details of the latest updates from Norfolk County Council (NCC) Highways Department is attached at appendix i.
- 7.1b The Clerk has requested a meeting with NCC Highways to discuss various concerns (including those outlined in the last meeting minutes ref 5/6 7); whilst the Highways Engineer confirmed they would be willing to meeting, no meeting date has been offered yet.
- 7.2 New issues reported are listed at appendix ii.
- 7.3 After reviewing options for funding for the proposed Trod between Stow Bridge Village Hall to the bus stop on The Causeway, in particular the changes to the Community Infrastructure Levy criteria, Council Members felt that match funding for this project may prove difficult to secure and that further research was needed to ensure the best chance of success; they therefore **RESOLVED** to put the project on hold until 2026.
- 7.4a The Road Closures Working Group reported that, after considering where and when parish specific signage might be useful, they had concerns about how useful this would actually be in practice. Potential issues they identified included: the parish not being informed in a timely manner of the exact location of any closure (or indeed in some cases, not being

- informed at all); whether the road was fully closed or passable; signs (belonging to the parish) being removed by NCC after the closure and therefore 'lost' to the parish.
- 7.4b It was agreed that one option would be to hold blank signs that could be changed according to where the road closures were, and that this should be trialled using temporary signs to see if it was worthwhile pursuing on a long-term basis.

- 8.2 Due to Npower not taking payment for an outstanding invoice, there has been no progress on changing energy supplier; the Clerk has spoken to Npower and been assured the matter should be resolved soon.
